The project focused on ensuring that we not only maintained our current continuity of operations, but identified opportunities for improvements. Critical to our success was the engagement, commitment and education of the many management teams spanning across our large organizational infrastructure.

Cyber Attack Exercising – Approach and Lessons Learned

What would happen if your primary and secondary networks were brought down? Do you know if you can recover? We know what would happen because we tested it. This year we simulated a large scale Cyber Attack involving roughly 70 technical experts within LMC. 8 Steps to make sure your Business Continuity Plan is not a Procedure Manual



Although your business continuity plan should have specific tasks and steps, it is important to not duplicate or use it as a procedure manual. A business continuity management (BCM) program is complex, spanning multiple scenarios, across matrixed processes and possibly hierarchies. It could be integrated into operational, financial, structural and social aspects. A procedures manual it is not! This presentation will walk you through 8 steps that will help you develop a BCM plan that meets management objectives, utilizes industry best practices, manages cost & resource constraints, and achieves optimal business continuity capability.
